# The Prevent Duty: risk assessment for Chapmanslade C of E Primary School 2024-2025

Risk Description	Action Requirements
High Risk	Risk will be actively managed with control measures.
Medium Risk	Monitor and take appropriate action to reduce risk if possible.
Low Risk	Risk to have low priority in the risk register.

### Chapmanslade Primary School Prevent duty risk assessment

Children may be susceptible to radicalisation into terrorism. Similar to protecting children from other forms of harms and abuse, protecting children from this risk should be a part of a schools safeguarding approach.

**Extremism** is the vocal or active opposition to our fundamental values, including democracy, the rule of law, individual liberty and the mutual respect and tolerance of different faiths and beliefs. This also includes calling for the death of members of the armed forces.

**Radicalisation** is the process of a person legitimising support for, or use of, terrorist violence.

**Terrorism** is an action that endangers or causes serious violence to a person/people; causes serious damage to property; or seriously interferes or disrupts an electronic system. The use or threat must be designed to influence the government or to intimidate the public and is made for the purpose of advancing a political, religious or ideological cause.

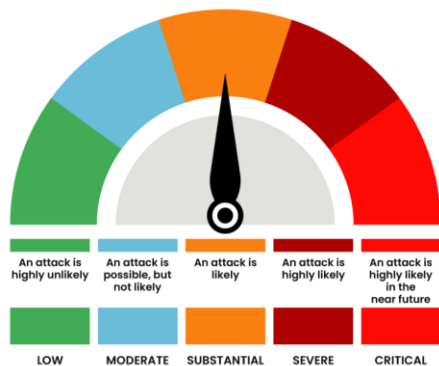
### **National Risk**

The current threat from Terrorism and Extremism in the UK is real and severe and can involve the exploitation of vulnerable people, including children to involve them in extremist activity.

**The current threat level is SUBSTANTIAL.**

The threat of a terrorist attack in the UK is currently assessed as SUBSTANTIAL, meaning an attack is likely. This was lowered on 9th February 2022.

The most recent terrorist attack in the UK was the Hartlepool attack in 2023 where one man died and another seriously injured. The defendant had expressed, during the time of his arrest and whilst in custody, that his actions were inspired by the Israel-Hamas conflict. He was subsequently sentenced to life imprisonment.



There are extremist groups operating online to recruit individuals and groups to join their organisations to spread hate messages against groups/faiths/women etc. Individuals who have been radicalised pose a risk to the public. They may be travelling on public transport, in public places at events, or try to gain access to public buildings and carry out an act of terrorism.

### **Local Risk - South West Counter Terrorism Local Profile (CTLP) 2024**

#### **A CTLP summary approved by Counter Terrorism Policing SW**

In July 2024, the most recent CTLPs were released by each police force area in the SW. The CTLPs provide an updated summary of the threat and risk across the region and at force level.

The predominant ideologies seen in the SW in both Prevent referrals and police investigations are Extreme Right-Wing Terrorism (ERWT) and Islamist Terrorism (IT) and to a lesser extent Left Wing and Single-Issue Terrorism (LASIT).

## Emerging Issues – Israel-Hamas Conflict

Previous conflicts in Gaza have led to a spike in antisemitic hate crime and pro-Palestinian protests throughout the UK. Work is ongoing to try and understand any long-term impact or radicalising influences within the SW.

Since the start of the Israel-Hamas conflict, there has been an increase in reporting in support of Hamas in Wiltshire based on previous trends and the ongoing conflict. The ongoing conflict will likely continue to heighten tensions amongst the Jewish and Muslim communities.

Having an understanding of these ideologies will help to identify anyone suitable for Prevent referral and also support confidence in counter narrative. Remembering you should consider/identify the ideology when considering a Prevent referral.

## Islamist Inspired Terrorism

We're most likely to be impacted by Islamist Terrorist groups and ideologies which arise from extremist interpretations of Islam, and the establishment of Islamic states and revenge against the West for perceived wrongs against Muslim people. The terrorist groups originate from countries such as Syria, Iraq, Middle East, West Africa and Afghanistan and include groups such as Al Qaeda (AQ) and Islamic State of Iraq and the Levant (ISIL). The tactics used may not to direct attacks but influence, and the UK remains a priority target.

## Extreme Right-Wing Terrorism

Classified by three ideologies (see below) remains a threat mainly due to the online sharing of material, memes and discussion. Proscribed terrorist groups such as Feuerkrieg Division, Sonnenkreig Division and Atomwaffen Division continues to influence.

- **White Supremacy** - belief that the 'white race' has certain inalienable physical and mental characteristics that makes it superior,
- **White Nationalism** - belief that mass migration from the 'non white' world, and demographic change, poses an existential threat to the 'white race' and 'western culture'.
- **Cultural Nationalism** - belief that 'western culture' is under threat from mass migration into Europe and from a lack of integration by certain ethnic and cultural groups.

## Left-Wing and Single Issue Terrorism (LASIT)

With a well-established footprint in the SW, this ideology includes activity such as extreme environmental, incel motivated behaviours and animal rights terrorism, mainly evident through low level protest and activism.

The use of the **online** space continues to be a significant risk with the viewing of online material having the potential to encourage self-initiated terrorism/attacks (S-IT). In addition, a notable threat is the online sharing of propaganda and extremist material (potential Terrorism Act offences), and recruitment into extremist and/or terrorist organisations.

We continue to see significant increases in those aged under 18 under investigation/arrested both nationally and regionally most notably with online offences - supporting why early intervention via Prevent is so important.

### **Self-Initiated Terrorist (S-IT)**

Self-initiated terrorists are the UK's most likely threat due to the difficulty to predict and detect potential attacks and the use of low sophistication easily accessible weapons such as vehicles and bladed weapons. Often influenced by online material and extreme content and are classified as being individuals or small groups who may be inspired or encouraged by organised terrorist groups but threaten or mobilise to violence without direction or material support.

**Common to all these ideologies is the use of the online space to help recruit, radicalise, and share materials so online safety and security is vital in helping safeguard our learners.**

### **PREVENT**

- There was an increase in the number of referrals to Prevent to 2022 (+8%), with some relating to individuals who have been referred multiple times over the past few years.
- The highest volume of Prevent referrals came from the education sector, specifically schools (48% of all referrals).
- The majority of referrals were male, predominately aged under 30 years, although there was a small increase in the number of female referrals compared to 2022.
- Prevent referrals continue to feature individuals who display a number of complex issues and vulnerabilities which influences their behaviour, and the vast majority of cases were closed with no CT Concerns.

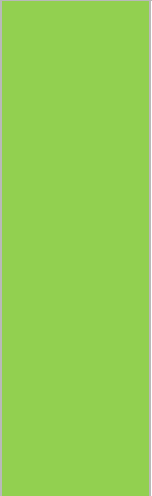
